Americans with Disabilities Act (ADA) Coordinator and Information

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990 (ADA), the City of Midway will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities. **Employment:** The City of Midway does not discriminate on the basis of disability in its hiring or employment practices and complies with all regulations promulgated by the U.S. Equal Employment Opportunity Commission under Title I of the ADA. **Effective Communication:** The City of Midway will generally, upon request, provide appropriate aids and services leading to effective communications for qualified persons with disabilities so they can participate equally in City of Midway's programs, services, and activities, including qualified sign language interpreters, documents in Braille, and other ways of making information and communications accessible to people who have speech, hearing or vision impairments. **Modifications to Policies and Procedures:** The City of Midway will make all reasonable modifications to policies or procedures to ensure that people with disabilities have an equal opportunity to enjoy all of its programs, services, and activities. For example, individuals with service animals are welcome in the City of Midway's facilities/properties, even where pets are generally prohibited. Anyone who requires an auxiliary aid or service for effective communication, or a modification of policies or procedures to participate in a program, service or activity of the City of Midway, should contact the City's ADA Coordinator as soon as possible but no later than forty-eight (48) hours before the scheduled event. The ADA does not require the City of Midway to take any action that would fundamentally alter the nature of its programs or services, or impose an undue financial or administrative burden. Complaints that a program, service, or activity of the City of Midway is not accessible to persons with disabilities should be directed to the ADA Coordinator as listed above. The City of Midway will not place a surcharge on a particular individual with a disability or any group of individuals with disabilities to cover the cost of providing auxiliary aids/services or reasonable modifications of policy, such as retrieving items from locations that are open to the public but not accessible to persons who use wheelchairs.

Equal Employment Opportunity (EEO) Coordinator and Information

The City of Midway certifies that it complies with the Equal Employment Opportunity Laws of the United States and that it shall require contractors that it hires with funds provided through the Community Development Block Grant Program (CDBG) to comply with the Equal Employment Opportunity Laws of the United States.
